Dear Resident:

Did you complete a pre-application form to pre-approve you for assistance with your new sewer connection? If you did we will be sending you an application in May 2016 to apply for the grant to be paid to a plumber to help with your sewer connection costs.

You must **own and reside** in your home to qualify for the grant. Your income must be below the 2015 income limits shown below, according to the number of persons in your household. I have enclosed a pre-application form, in case you didn't complete and mail one previously. Feel free to send it back in even if it may be a duplicate and we will send an application to you in May 2016.
